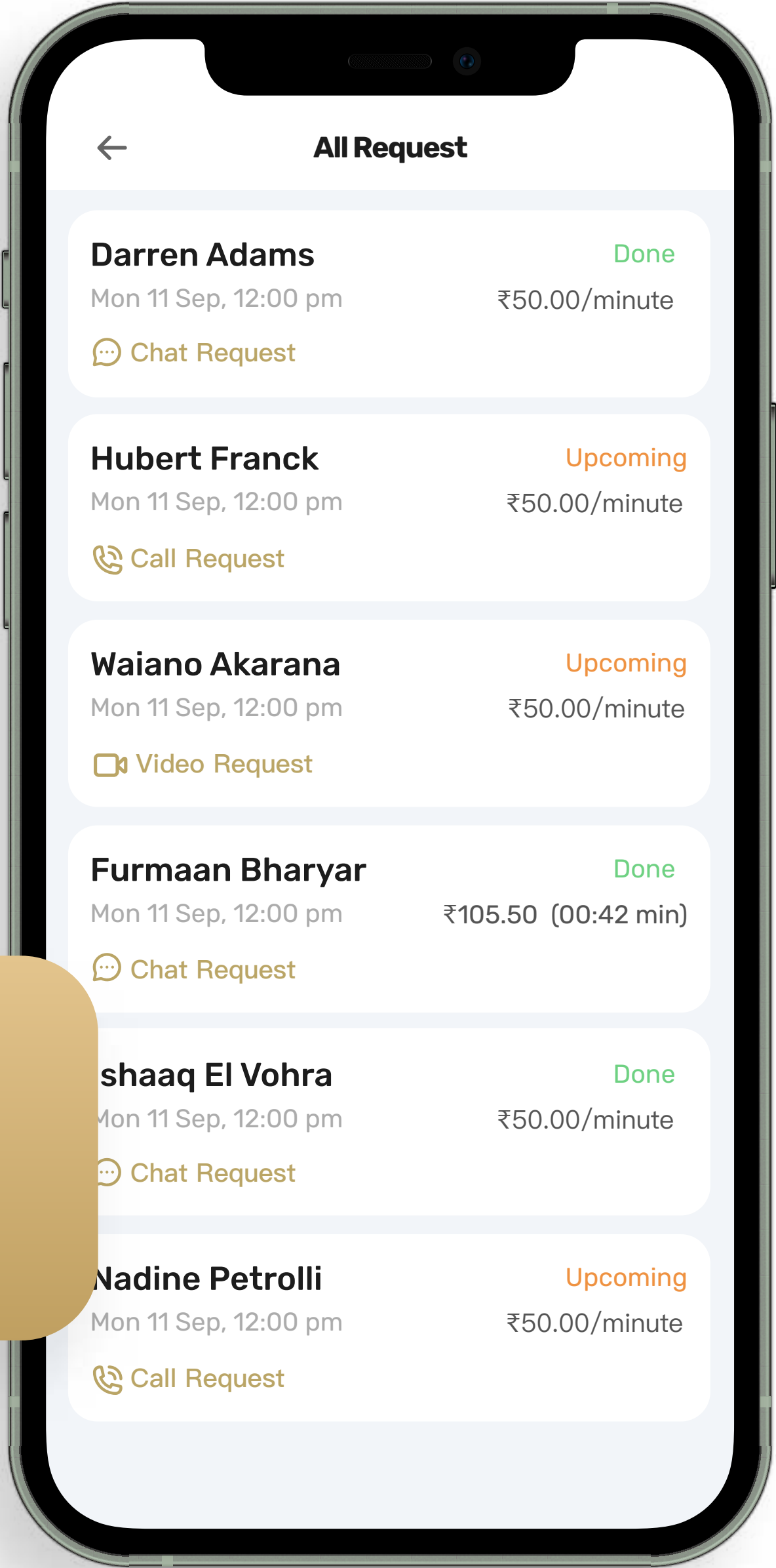
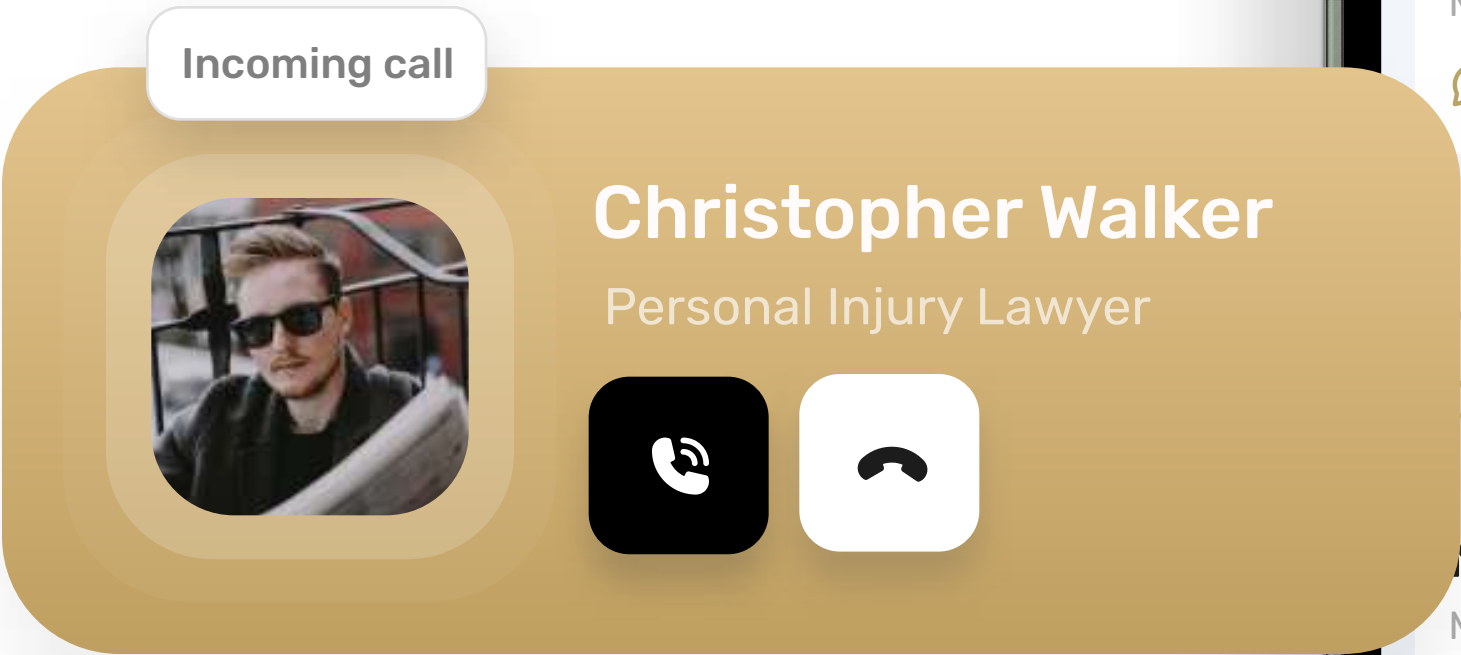


Chat Consultation
